**IMPORTANT NOTICE OF MEDIATION FOR EVICTION CASES ONLY**

**You are being served with an eviction complaint which could result in losing your housing and possibly paying the Plaintiff money. Call the Kane County Eviction Mediation Program to learn more about the eviction and mediation process.** Only you or a lawyer can appear in court on your behalf. You may not send a friend or relative in your place. There are resources available for people in your situation.

**Mediation can help you avoid eviction.**

Mediation is a safe space with a neutral third party to help landlords and tenants communicate to voluntarily and mutually resolve issues outside of court. Your attorney may attend the mediation with you. Mediation is a free alternative to the court process, but there is no guarantee that an agreement may be reached by both parties. All discussions are confidential.
