WHEREAS, initial case management conferences are randomly scheduled by the Clerk of the Circuit Court on certain civil case types upon filing, including Residential Foreclosures; and

WHEREAS, the 16th Judicial Circuit has established a Mandatory Residential Foreclosure Mediation Program (Program) pursuant to Illinois Supreme Court Rules; and

WHEREAS, in order to timely meet and promote the stated goals of the Program, it is in the interests of justice to allow the plaintiff to designate the day of the week, but not the date, of the initial case management conference;

WHEREFORE, IT IS HEREBY ORDERED:

- 1) Commencing on June 15, 2015, the plaintiff may file a written designation of the day or days of the week requested for the initial case management conference simultaneously with any Residential Mortgage Foreclosure complaint.
- 2) The written designation must be filed as a separate document from the complaint in substantially the same form attached hereto as Exhibit A.
- 3) Only designations filed simultaneous with the complaint may be accommodated by the Clerk of the Circuit Court in setting the initial case management conference; written designations not accompanying the complaint will not be accommodated.
- 4) If no written designation is filed, the Clerk of the Circuit Court shall schedule an initial case management conference on a random date within the applicable time period set by order or rule, which may fall on any day of the week that court is in session.
- 5) For those cases in the Mandatory Residential Mortgage Foreclosure Mediation Program, the Program Coordinator will give reasonable consideration to any day or days designated by the plaintiff when scheduling any future court dates during the Program.
- 6) This order does not affect the ability of any party to properly schedule and notice up a motion to continue a scheduled case management conference or any other date.
