#### IMPORTANT NOTICE OF MEDIATION FOR EVICTION CASES ONLY

You are being served with an eviction complaint which could result in losing your housing and possibly paying the Plaintiff money. Call the <u>Kane County Eviction Mediation Program</u> to learn more about the eviction and mediation process. Only you or a lawyer can appear in court on your behalf. You may <u>not</u> send a friend or relative in your place. If you want to talk to a lawyer about your case, ask the judge for a continuance. There are resources available for people in your situation.

### Mediation can help you avoid eviction.

Mediation is a process where a neutral third party helps landlords and tenants communicate to resolve issues through voluntary, mutual agreement. Your attorney may attend the mediation with you. Mediation is a free alternative to the court process, but there is no guarantee that an agreement may be reached by both parties. All discussions are confidential.
